BLOOMINGTON, III. – County Farm Bureau leaders in the $117^{\rm th}$ House District serving as trustees for Illinois Farm Bureau ACTIVATOR® — the organization's political action committee — are endorsing Rep. Patrick Windhorst for re-election.

Windhorst was unanimously endorsed when county Farm Bureau leaders met to discuss his current voting record.

If elected, Windhorst will serve the new 117th House District, which accounts for close to 60% of the district he currently represents. The new area includes all or part of Gallatin, Hamilton, Hardin, Johnson, Massac, Pope, Saline, Franklin, White and Williamson counties.

Windhorst was appointed to the state House of Representatives in 2018 and has positively impacted rural communities during his short time in office. In 2019, he introduced and helped pass legislation to create the Rural Economic Development Task Force to evaluate the conditions, needs and issues in agriculture. The task force, which he currently sits on, also helped identify actions and legislation needed to promote economic development in rural communities.

Windhorst has proven he's a friend to agriculture by supporting legislation that benefits farmers. He's helped create processes for landowners to work more closely with local highway commissioners and has also helped protect private property rights by opposing the use of eminent domain by private utility companies. In addition, he's encouraged health departments to expand market opportunities for small farmers in the food industry.
