BLOOMINGTON, Ill. – County Farm Bureau leaders in the 37<sup>th</sup> Illinois Senate District serving as trustees for Illinois Farm Bureau ACTIVATOR® – the organization’s political action committee – unanimously endorsed Sen. Win Stoller for re-election.

Stoller was unanimously endorsed when county Farm Bureau leaders met to discuss his current voting record.

The new 37<sup>th</sup> Senate District will span across Bureau, DeKalb, Henry, LaSalle, Lee, Marshall, Ogle, Peoria, Rock Island, Stark, Whiteside and Woodford counties.

While in the Senate, Stoller has worked with Illinois Farm Bureau and his local agricultural advisory committee to guide him on decisions regarding agricultural issues. In 2021, he sponsored and passed local highway authority transparency legislation, an Illinois Farm Bureau legislative priority. He also stood with Illinois Farm Bureau in support of property rights and agricultural tax incentives while voicing opposition to the imposition of unnecessary and burdensome regulations.
